



Data Protection









3 Installation



- 1. Open the case door with key and disassemble the case door.
- 2. Disassemble the protection cover on the power supply.



- 3. Secure the case body on the mounting area.
- 1) Drill holes on the mounting area according to the mounting holes at the bottom of the case body.
- 2) Instert the expansion sleeves into the drilled holes.
- 3) Align the case body and the drilled holes. And secure the case body on the mounting area with 3 set screws (PA4 × 35).
- 4) Complete the wiring inside the case.



- 4. Assemble the protection cover back.
- 5. Assemble the case door back.



5. Finish installation.
