1.1 Front Panel




Figure 1-1 Front Panel

Table 1-1 Panel Description

No.	Name	Function Description
1	Power button	<ul style="list-style-type: none"> ● Press it to power on device. The button is blue when device is on. ● Hold it for 3 seconds to force shut down the device.
2	Status indicator	<ul style="list-style-type: none"> ● Solid blue: System is normal. ● Unlit: System is abnormal.
3	Reset button	Press it to restore device to defaults.
4	USB interfaces	Two USB 2.0 interfaces for connecting USB devices.
5	Alarm indicator	Solid red when motherboard is abnormal.
6	UID indicator	Used to position server. It is blue when UID is on.
7	UID button	Turn on/off UID indicator.




Figure 1-2 Rear Panel

5	Power supply	Power supply

Chapter 2 Installation

2.1 Installation Instruction

Before installing the server, please be advised of following tips:

- Check the delivered package. If any object is damaged or lacked, please contact the dealer.
- Ensure the server is installed in a well-ventilated, dust-free environment.
- Keep away from hot source, electric noise, and electromagnetic field.
- To ensure adequate airflow and safety, install the server in a dedicated rack.
- Use a rack with enough bearing capacity. And properly keep the server.
- To ensure adequate airflow and convenient maintenance, deploy sufficient room for rack and wall.
- Provide the server with rated power supply.
- Do not share server power socket with other devices.
- Ensure the rack is correctly grounded.
- It is highly recommended that an Uninterruptible Power Supply (UPS) is used in conjunction with the server.
- As a Class A product, the server may cause radio interference. You are recommended to take practical measures for the interference.

2.2 Uninstall Power Module

Purpose:

Follow the steps to uninstall power modules.

Step 1 Unlock the power module via the spring bolt.

Step 2 Pull the power module out of the server.

2.3 Server Installation

Purpose:

Follow the steps to install the rear part of inner rails in the server. The front part has been installed when delivered.

 **NOTE**

Rack requirement: The distance between the front column and rear column ranges from 660 to 850 mm.

2.3.1 Inner Rail Installation

Purpose:

Follow the steps to install the rear part of inner rails in the server. The front part has been installed when delivered.

Step 1 Confirm that the left and right inner rails have been correctly identified.

Step 2 Place the inner rail firmly against the side of the chassis, aligning the hooks on the side of the chassis with the holes in the inner rail.

Step 3 Forwards slide the inner rail towards the front of the chassis until the rail clicks into the locked position, which secures the inner rail to the chassis.

Step 4 Secure the inner rail to the chassis with two M4 sunk screws.

Step 5 Repeat step 1 to 4 to install the other inner rail.




Figure 2-1 Fix Server and Inner Rails

2.3.2 Outer Rail Installation

Follow the steps to install two outer rails into rack.

Step 1 Fix the delivered M5 cage nuts in rack columns with six in front columns and four in rear.

Step 2 Hang the hooks of the front of the outer rail onto the slots on the front of the rack.

Step 3 Use M5 × 10 screw to secure the rear end of outer rails to the rack.

Step 4 Pull out the rear of the outer rail, adjusting the length until it fits the rear column.

Step 5 Hang the hooks of the rear portion of the outer rail onto the slots on the rear of the rack.
Use M5 × 10 screw to secure the rear of the outer rail to the rear of the rack.

Step 6 Repeat the above the steps to fix the other outer rail.




Figure 2-2 Install Outer Rails

2.3.3 Installing Server into a Rack

Before you start:

Confirm that the inner rails are properly installed on the chassis and the outer rails are correctly installed on the rack.

Step 1 Align the chassis inner rails with the front of the outer rails.

Step 2 Slide the server into the rear of the rack along the outer rail.

Step 3 Fix the server and outer guide rail with screws.

 NOTE

If you need to pull out the server from the rack, push the left locking tab in inner rail upwards and then push the left one downwards.




Figure 2-3 Installing Server into Rack
